Terms & conditions

These terms and conditions apply to all agreements concluded with psp business abroad (psps or its executors to participate in the "Netherlands Pavilion at HANNOVER MESSE 2026"). In addition, the [general terms and conditions](#) of psp business abroad apply.

1. The company or institution must be registered in the trade register of the competent Chamber of Commerce in accordance with the Trade Register Act 1996.
 2. Registration must take place by means of the participation form sent, completed, signed and returned to psp.
 3. **Deadline** for application is no later than **31.12.2025**. Possible additional wishes must be discussed separately and confirmed in writing (by e-mail). Manual additions to the participation form will not be accepted. **Participants who have registered prior to 21.11.2025 can indicate their preferred placement on the pavilion. This is on a first come, first serve basis.** Due to this, no guarantees can be given on the final placement.
 4. Registration is binding 48 hours after registration. No cancellation is possible without costs. Cancellation by the participating company does not affect the obligation to pay the entire participation fee and any further financial consequences of the cancellation.
 5. For participation in the Netherlands Pavilion with an own booth, prices as described in page 1 will be invoiced according to the chosen package. [Through the Support International Business \(SIB\)](#) subsidy you will be able to apply for a subsidy covering 50% of the participation costs (up to €2.500), excluding travel & accommodation costs. For this amount you will receive: a working station (1 standing wall with graphic panel, 1 43 inch television, 1 cube desk, 1 chair) with 230V electricity and internet access. You will also receive access to our prep. seminars and coaching, networking event and catering. The costs are excl. travel and accommodation expenses. Costs for transport, insurance of the exhibition goods and extra facilities in the stand are at your own expense.
- In case of force majeure, or an official cancellation of the Hannover Messe by the German government, psp assumes, that in case of cancellation by the Hannover Messe (see above), no costs will be passed on by the trade fair organization to its participants. If, due to one of the aforementioned reasons, the trade fair organization cancels the fair and decides to pass on costs to its participants, this amount will not exceed 50% of the original participation fee.
6. When applying for the Netherlands Pavilion, the participant commits to a formal trade fair registration through The Hannover Messe.
 7. psp has contracted a stand construction company for the realization of the Netherlands Pavilion at the Hannover Messe. By registering, the participant commits to using the booth and stand construction offered by psp and the contractor. psp will be responsible for coordination between the Stand Constructor and the Netherlands Pavilion participants.
 8. After registration, the participant will receive an invoice for the entire amount including VAT on January 5th 2026, unless mentioned otherwise.
 9. Payment should be made within 10 days of receipt of the invoice. Should the payment not be received in time by psp, psp reserves the right to exclude the participant in question from participation. All consequences of such cancellation shall be borne by the company concerned.
 10. The participant is responsible for the timely (BEFORE the trade fair) application of his/her own subsidy and the associated EH2+ e-recognition (e-herkenning). If the participant is not granted the subsidy by the Netherlands Enterprise Agency (RVO), psp business abroad cannot be held liable and the participant is still obliged to pay the complete participation fee in accordance to the chosen package.
